## A-201 Pricing Order for TC Chicken

To: All Processors & Growers

The British Columbia Chicken Marketing Board orders as follows:

The minimum prices to be paid by Processors to Growers for Taiwanese chicken marketed in the Province of British Columbia on all product contracted for or otherwise designated by the Board to be shipped in the Period A-201 (March 8, 2026 – May 2, 2026) shall be as follows:
